MINUTES

A Special Meeting of the Mississippi Autism Board ("Board") was called to order on Friday, May 20, 2022, at 11:30 a.m. by board member, Dr. Emily Johnson. The meeting took place in person at the Woolfolk Building in Jackson, MS.

Call to Order:
